Terms of Agreement for 9 Hour Ultimate Preparation Driving Instruction

This agreement for driving instruction is service between **A-Team Driving School** and _____ (parent/guardian) and _____ (student) who reside at _____ (address).

A-Team Driving School will provide 9 hours of driving instruction by a NJ licensed instructor to _____ (student) for the agreed upon fee of **\$655.00**. If paying by credit or debit card a **3%** fee will be charged. Payment must be made by cash, check, credit, debit, or money order prior to the beginning of the first lesson. There is a **\$10.00** fee for purchase of the permit through NJDMV. The permit will be purchased for the student by the school either prior to or at the first lesson. If the pickup/drop off location is **30 minutes or more** from 244 N. Main Street Mullica Hill, NJ there will be a **surcharge of \$25**.

Prior to driving instruction, a student must pass a written and vision screening. The vision screening is administered at our office through a certification provided by the NJDMV. This may be done anytime prior to or at the beginning of the first lesson with the instructor. Upon successful completion, the student will begin behind-the-wheel driving instruction consisting of (3) three-hour lessons beginning and ending at a time that has been previously scheduled and agreed upon by both parties. The purpose of the 9 hour driving course is to build confidence in student driving skills and to reinforce what is taught during the 6 hour course. These extra lessons are to assure added confidence in the students driving ability. The written test may have been completed at the student's high school, where a passing score would result in the possession of a waiver test receipt. If a student does not have his or her test receipt, they must take the written test at least 1 week prior to their first lesson. This can be done either at our office (student must be 16 years of age) or the student's high school.

The vehicle is equipped with all safety and instructional equipment required according to the standards of NJ NJDMV; including: automatic transmission, dual brakes (student and instructor), front air bags, seat belts for all passengers and anti-lock brakes. The radio or CD player will NOT be in operation during instruction.

Any health problems that a student has must be clearly stated and any medications that could impair driving must be identified prior to any instruction. The A-Team Driving School reserves the right to reschedule any lesson without prior notice if the instructor believes the health of the student at the time of the lesson is such that that the student, instructor or any motorist would be in jeopardy.

This contract is not assignable without the express prior written consent of A-Team Driving School. If any of the provisions of this Agreement are held to be invalid or unenforceable, or if any of the said provisions are modified in writing due to a change in circumstances of either of the parties hereto, all other provisions shall, nevertheless, continue in full force and effect.

A modification and waiver of any of the provisions of the Agreement shall be effective only if made in writing and executed with the same formality as this Agreement. The failure of either party to insist upon strict performance of any of the provisions of this Agreement shall not be construed as a waiver of any subsequent default of the same or similar nature. No other verbal



statements will supersede this Agreement. Any alterations or adjustments to the contract's terms must be initialed by both parties and written in the comments section of this document.

A-Team driving school will have an instructor pick-up the student at either their home or their school, whichever is preferred. A-Team Driving School will also drop-off the student at their home or a previously specified and agreed upon location.

Students will not be permitted to eat or drink during driving instruction. Students may bring a drink/snack in a small cooler which they will have access to at a time which is deemed safe by his or her instructor. Smoking or other forms of tobacco/alcohol use is not permitted and will result in an immediate cancellation of the lesson without refund. Proper attire must be worn (no flip-flops, high heels, or bare feet"

A-Team Driving School reserves the right to refuse, cancel or reschedule any lesson without prior notice if the instructor deems it necessary to do so due to safety, health or any other concerns made at the instructor's or school's discretion.

No refunds will be issued after the student's permit has been purchased by A-Team Driving School. A refund may be issued prior to the purchase of the permit, a **\$50.00** processing fee will be charged. If a lesson (s) is rescheduled/canceled within **(7) seven calendar days** of the scheduled lesson(s), a **\$50.00** processing fee will be charged in order to reschedule the lesson(s).

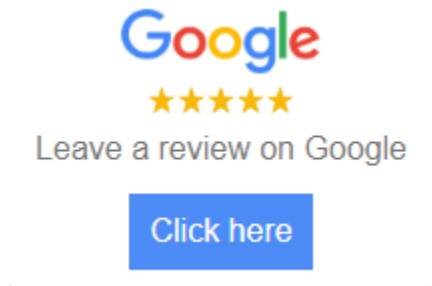

GDL DRIVING RESTRICTIONS

Special Learner's Permit (16 years old)

- May not operate a vehicle between 11:01pm and 5:00am
- May not use a hand-held or hands-free electronic device (ex. Cell phone)
- Must have a supervising driver 21 years or older who has had a license for 3 years in passenger seat
- Only one additional passenger in car (not including supervising driver) unless accompanied by a parent
- If a GDL driver is over the age of 21, the passenger and time restrictions do not apply
- Must display red GDL decal in upper left corner of front and rear license plate

Examination Permit (at least 17 years old)

- Same as above

Probationary License

- May not operate a vehicle between 11:01pm and 5:00am
- May not use a hand-held or hands-free electronic device (ex. Cell phone)
- Only one additional passenger in car unless accompanied by a parent
- Must display red GDL decal in upper left corner of front and rear license plate

***Failure to abide by any of the GDL restrictions is subject to a \$100 fine - N.J.S.A. 39:3-13.8**

I certify that any supervised driving hours were completed under the immediate supervision of a person at least 21 years of age who holds a valid New Jersey license to operate the type of vehicle that was used.
